<b>A1069 Braunstein S947 Avella</b>	<b>Relates to dividing the one hundred fifth and one hundred ninth precincts of the New York city police department into subdivisions</b>
<b>A1508 Braunstein S687 Avella</b>	<b>Requires that one of the members of the board of standards and appeals be a financial analyst</b>
<b>A301 Dinowitz S1339 Klein</b>	<b>Dedicates and designates Jerome Park as parklands of the city of New York and establishes a working group for such park to enhance the use thereof</b>
<b>A3293 Titone S3319 Lanza</b>	<b>Provides that new streets within and abutting streets of new commercial projects in the city of New York be the maximum legal width</b>
<b>A3405 Titone S3473 Lanza</b>	<b>Prohibits the imposition and collection of tolls for the passage of motor vehicles over highways in a city having a population of one million or more</b>
<b>A3564 Brennan S1310 Peralta</b>	<b>Increases civil penalties for violations of building maintenance standards within the city of New York</b>
<b>A3634 Braunstein S4419 Lanza</b>	<b>Relates to the declaration of a sign as a public nuisance and its removal</b>

<p><b>A4130 DenDekker S1134 Avella</b></p>	<p><b>Requires the New York city department of sanitation to remove any snow or ice accumulation in front of any fire hydrants</b></p>
<p><b>A6046 Abbate S4269 Golden</b></p>	<p><b>Relates to the disability benefits of members of the New York police and fire pension funds</b></p>
<p><b>A660 Braunstein S1099 Avella</b></p>	<p><b>Requires the department of buildings to maintain a registry of all deeds containing restrictive covenants</b></p>
<p><b>A6797 Crespo S4425 Peralta</b></p>	<p><b>Directs cities having a population of two million or more to establish a vendor policy commission to review and make recommendation on the laws and rules applicable to street vendors</b></p>
<p><b>A6832 Crespo S1338 Klein</b></p>	<p><b>Relates to purposes of licensing by the department of consumer affairs in the city of New York, includes businesses offering certain adult entertainment within the definition of "cabaret"</b></p>
<p><b>A6860 Crespo S2293 Dilan</b></p>	<p><b>Provides that owners of real property in the city of New York shall designate the address or addresses where such owner receives their daily or regular mail</b></p>
<p><b>A6914 Simon S175 Squadron</b></p>	<p><b>Authorizes the city of New York to provide for a residential parking permit system</b></p>
