## Summary of Res. 0742-2025: Support for the Mayfield Act (S.1209/A.1297) to Eliminate **Mandatory Minimum Sentences**

## **Purpose:**

This resolution expresses the New York City Council's support for the Mayfield Act (S.1209/A.1297), which would eliminate mandatory minimum sentencing laws in New York State and restore judicial discretion in sentencing decisions.

#### **Key Points:**

#### 1. Background on Mandatory Minimums:

- Introduced in the 1970s under the **Rockefeller Drug Laws**, mandatory minimums removed judicial flexibility by requiring set prison terms for certain crimes.
- Expanded in the 1990s, they included harsher penalties for repeat offenses and restricted parole options.

# 2. Criticism of Mandatory Minimums:

- **Ineffective** at deterring crime.
- Have contributed significantly to mass incarceration.
- Disproportionately impact Black, Latino, and low-income communities.
  - In 2019, 91% of those arrested for mandatory minimum-eligible crimes in NY were people of color.

## 3. Provisions of the Mayfield Act:

- **Eliminates mandatory minimum sentences** for prison, jail, and probation.
- Restores judicial discretion, allowing judges to consider individual circumstances and mitigating factors.
- **Ends sentencing mandates** based on prior convictions alone.
- **Prevents prosecutors** from restricting sentencing options through charging decisions or plea deal constraints.

#### 4. Policy Goals:

- Advance **fairness and rehabilitation** over punitive incarceration.
- Reduce **racial disparities** in sentencing.
- Empower judges and shift influence away from prosecutorial overreach.
