### REPORT OF THE COMMITTEE ON FINANCE

#### **RESOLUTION APPROVING THE NEW DESIGNATION AND CHANGES IN THE DESIGNATION OF CERTAIN ORGANIZATIONS TO RECEIVE FUNDING IN THE FISCAL 2008 AND FISCAL 2009 EXPENSE BUDGETS.**

The Committee on Finance, to which was referred the above-captioned resolution, respectfully submits to The Council of the City of New York the following

#### **R E P O R T**

Introduction. The Council of the City of New York (the “Council”) annually adopts the City’s budget covering expenditures other than for capital projects (the “expense budget”) pursuant to Section 254 of the Charter. On June 29, 2008, the Council adopted the expense budget for fiscal year 2009 with various programs and initiatives (the “Fiscal 2009 Expense Budget”). On June 15, 2007, the Council adopted the expense budget for fiscal year 2008 with various programs and initiatives (the “Fiscal 2008 Expense Budget”).

Analysis. This Resolution, dated April 22, 2009, approves new designations and changes in the designation of certain organizations receiving local, aging, and youth discretionary funding in accordance with the Fiscal 2009 Expense Budget. In addition, this Resolution approves the new designations and changes in the designation of certain organizations to receive funding pursuant to certain initiatives in the Fiscal 2009 Expense Budget.

Additionally, this Resolution approves new designations of certain organizations to receive funding pursuant to certain initiatives in the Fiscal 2008 Expense Budget.

In an effort to continue to make the budget process more transparent, the Council is providing a list setting forth new designation and/or changes in the designation of certain organizations receiving local, aging, and youth discretionary funding (or Council discretionary funding), as well as new designations and/or changes in the designation of certain organizations to receive funding pursuant to certain initiatives in the Fiscal 2009 Expense Budget.

This resolution sets forth new designations and specific changes in the designation of certain organizations receiving local initiative funding, as described in Chart 1, attached hereto as Exhibit A, sets forth new designations and changes in aging discretionary funding, as described in Chart 2, attached thereto as Exhibit B, sets forth new designations and specific changes in the designation of certain organizations receiving youth discretionary funding, as described in Chart 3, attached thereto as Exhibit C, sets

forth the new designations of certain organizations that will receive funding pursuant to certain initiatives in the Fiscal 2009 Expense Budget, as described in Charts 4-24, attached hereto as reflected in Exhibits D-W, and sets forth new designations of organizations that will receive funding pursuant to certain initiatives in the Fiscal 2008 Expense Budget, as set forth in Charts 25-26, as reflected in Exhibits Y and Z.

The charts, attached to the resolution, contain the following information: name of the council member(s) designating the organization to receive funding or name of the initiative, as set forth in Adjustments Summary/Schedule C/ Fiscal 2009 Expense Budget, dated June 29, 2008, or the Adjustments Summary/Schedule C/ Fiscal 2008 Expense Budget, dated June 15, 2007; name of the organization; organization's Employer Identification Number (EIN), if applicable; agency name; increase or decrease in funding; name of fiscal conduit, if applicable; and the EIN of the fiscal conduit, if applicable.

Specifically, Chart 1 sets forth the new designation and changes in the designation of certain organizations receiving local discretionary funding. Chart 1 also indicates a EIN correction. Chart 1 reflects EIN 33-1169339 as the proper EIN for New Lane Shores Tenant Association.

Chart 2 sets forth the new designation and changes in the designation of certain organizations receiving aging discretionary funding. Chart 2 also indicates an EIN correction. Chart 2 reflects EIN 11-2649513 as the proper EIN for American-Italian Coalition of Organizations, Inc. (AMICO).

Chart 3 sets forth the new designation and changes in the designation of certain organizations receiving youth discretionary funding. Chart 3 also indicates a fiscal conduit addition. Fourth Avenue Presbyterian Church/The Children's Community Chorus has designated the Bay Ridge Bensonhurst Beautification and Preservation Alliance as a fiscal conduit/sponsoring organization.

Chart 4 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Cultural After School Adventure Initiative.

Chart 5 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Immigrant Opportunity Initiative.

Chart 6 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Domestic Violence and Empowerment (DoVE) Initiative.

Chart 7 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Adult Literacy Initiative.

Chart 8 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Food Pantries Initiative.

Chart 9 sets forth the new designation and changes in the designation of a certain organization receiving funding pursuant to the HIV/AIDS Faith Based Initiative.

Chart 10 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Dropout Prevention and Intervention Initiative. As indicated in Chart 10, funding in the amount of \$75,000 for Asociacion Tepeyac De New York has been withdrawn. This amount will be used to fund El Puente de Williamsburg.

Chart 11 sets forth the new designation and changes in certain organizations receiving funding pursuant to the Alcoholism/Substance Abuse Initiative. As indicated in Chart 11, funding in the amount of \$37,228 for the Peninsula Hospital Center has been withdrawn. This money will be used to fund National Association on Drug Abuse Problems, Inc.

Chart 12 sets forth the new designation and changes in the designation of a certain organization receiving funding pursuant to the Infant Mortality Reduction Initiative. Chart 12 indicates a name correction and EIN correction. The proper name for this organization is Visiting Nurse Service of New York Home Care, Inc. The correct EIN for this organization is 13-1624211. Chart 12 reflects the proper designation of \$26,101.13 to Visiting Nurse Service of New York Home Care, Inc. with EIN 13-1624211. Also, as reflected in Chart 12, funding in the amount of \$19,586.25 for the New Dimensions in Care has been withdrawn. This money will be used to fund Bronx Health Link.

Chart 13 sets forth the new designation of certain organizations receiving funding pursuant to the Geriatric Mental Health Initiative. Chart 13 indicates a name correction and EIN correction. The proper name for this organization is Visiting Nurse Service of New York Home Care, Inc. The correct EIN for this organization is 13-1624211. Also, Chart 13 reflects an organization's name change from Fordham-Tremont Community Mental Health Center to St. Barnabas Hospital. Chart 13 reflects the proper designation of \$95,000 to St. Barnabas Hospital.

Chart 14 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Space Costs for Senior Centers Initiative within the Department for the Aging. As indicated in Chart 14, the result of the new designations and changes in the designations result in an addition of \$14,962.60. This additional amount will be transferred in an Initiative Fund Transfer, reflected in Chart 20.

Chart 15 sets forth changes in the designation of the Allen A.M.E. Neighborhood Preservation and Development Corp., an organization receiving funding pursuant to the Transportation Costs Initiative. As indicated in Chart 15, funding in the amount of

\$14,962.60 for this organization has been withdrawn. This amount will be used to fund the Space Costs for Senior Centers Initiative within the Department for the Aging in an Initiative Fund Transfer, reflected in Chart 20.

Chart 16 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Healthy Aging Initiative. Chart 16 indicates a name correction and an EIN correction. The proper name for this organization is Southeast Queens Multiservice Senior Center-Howard Beach Senior Center, Inc. The correct EIN for this organization is 23-7287548. Chart 16 reflects the proper designation of \$30,000 to the Southeast Queens Multiservice Senior Center-Howard Beach Senior Center, Inc. with EIN 23-7287548. Also, Chart 16 indicates an EIN correction for the American-Italian Coalition of Organization, Inc. (AMICO). Chart 16 reflects the proper designation of \$30,000 to American-Italian Coalition of Organization, Inc. (AMICO) with EIN 11-2649513.

Chart 17 sets forth the new designation and changes in the designation of a certain organization receiving funding pursuant to the Information and Referral Contracts Initiative. Chart 17 indicates an EIN correction for the American-Italian Coalition of Organization, Inc. (AMICO). The proper EIN for this organization is 11-2649513. Chart 17 reflects the proper designation of \$140,036.59 to American-Italian Coalition of Organization, Inc. (AMICO) with EIN 11-2649513.

Chart 18 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Housing Preservation Initiative. As indicated in Chart 18, funding in the amount of \$60,000 for the New Settlement Apartments has been withdrawn. This amount will be used to fund Crenulated Company, Inc.

Chart 19 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Comprehensive Podiatric Medical Screening Initiative.

Chart 20 sets forth the new designation and changes in certain organizations receiving funding pursuant to the Autism Awareness Initiative. As indicated in Chart 20, funding in the amount of \$50,000 for Eden II School for Autistic Children, Inc. has been withdrawn. This money will be used to fund Samuel Field YM & YWHA, Inc.

Chart 21 sets forth the new designation and changes in certain organizations receiving funding pursuant to the NYA Street Outreach Initiative. As indicated in Chart 21, funding in the amount of \$8,774.66 for Brooklyn Center for the Urban Environment has been withdrawn. This money will be used to fund the City Parks Foundation.

Chart 22 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Community Consultants Initiative.

Chart 23 sets forth an Initiative Fund Transfer between the Transportation Costs Initiative and the Space Costs for Senior Centers Initiative within the budget for the Department for the Aging. As indicated in Charts 15 and 23, funding for the Transportation Costs Initiative in the amount of \$14,962.60 has been withdrawn. This money will be used to fund Space Costs for Senior Centers Initiative, as reflected in Chart 23. The net effect of the Initiative Fund Transfer is zero.

Chart 24 sets forth the new designation of certain organizations receiving funding pursuant to the HIV/AIDS Communities of Color Initiative.

Chart 25 sets forth the new designation of certain organizations receiving funding pursuant to the Anti-Gang Initiative of Fiscal 2008. As such, it modifies the list of organizations designated to receive funding as set forth in Adjustments Summary/Schedule C/Fiscal 2008 Expense Budget, dated June 15, 2007. Funding in the amount of \$899,999.08 will be provided to organizations listed in Chart 25.

Chart 26 sets forth the new designation of Empire State Coalition of Youth and Family Services within the Homeless and Runaway Youth Population Count Initiative of Fiscal 2008. Chart 26 indicates a technical correction. This organization was omitted from the Adjustments Summary/Schedule C/ Fiscal 2008 Expense Budget, dated June 15, 2007. Chart 26 reflects the designation of \$17,500 to this organization as part of the Homeless and Runaway Youth Population Count Initiative for Fiscal 2008.

It is to be noted that organizations identified in the attached charts with an asterisk (\*) have not yet completed or began the prequalification process conducted by the Mayor's Office of Contract Services (for organizations receiving more than \$10,000) or by the Council (for organizations receiving \$10,000 or less total). Organizations identified without an asterisk have completed the appropriate prequalification review.

Description of Above-captioned Resolution. In the above-captioned resolution, the Council would approve the new designation and changes in the designation of certain organizations to receive funding in the Fiscal 2008 and Fiscal 2009 Expense Budgets. Such resolution would take effect as of the date of adoption.
