## Q1

From July 1, 2024 to Sept 30<sup>th</sup> 2024

1. The number of summonses issued for unlicensed cannabis: Issued 781 summons
2. The total amount of fines imposed: Total docketed amount is \$3,120,085.08
3. The amount of docketed fines collected: \$0
4. The amount of docketed fines uncollected within the reporting period and fiscal year to date: From July 1- Sept 30<sup>th</sup>, \$3,120,085.08 went uncollected. There were two docketed collections that have occurred but outside of the above reporting period so far for a total of \$20,157.97
