DEAR NEIGHBOR,

I am pleased to share with you some of our most significant legislative achievements from the last session as I welcome new neighbors into our district. As our District 45 has now expanded to include new residences in Midwood, Flatbush, East Flatbush, Marine Park, and Canarsie, I look forward to fostering community bonds with our new neighbors and ensuring that all voices are heard and represented in this new session.

I am honored to have been appointed as Chair of the Committee on Women and Gender Equity by Speaker Adrienne Adams, who will continue to lead our Council in the next session as a formidable force and partner in government for all my colleagues. As part of the most diverse and first women-majority Council, we have accomplished several crucial milestones that directly impact our communities across Central Brooklyn and the City of New York, and I am dedicated to championing legislative priorities that promote equitable opportunities for all women in New York City.

- One of my key accomplishments in the Council is making strides to promote Pay Equity and to address pay disparities across our municipal workforce. Through my leadership of the Pay Equity Package in the City Council, and with my bill signed by Mayor Eric Adams, Local Law 29 of 2023 (INTRO 541-A), we are ensuring transparency within our city agencies on pay scales and opportunities for advancement in careers for our municipal workforce.
- Promoting Financial Literacy remains a prime focus for me in this session, as I continue to provide advancements in socio-economic well-being in our community through education on responsible financial practices. My bill to mandate programs offered by the Department of Youth and Community Development (DYCD) is now Local Law 98 of 2023 (INTRO 54-A), and aims to equip our youth with essential financial literacy skills, fostering greater economic stability and success. Additionally, I take pride in funding AYO Labs and breaking ground on the first beauty manufacturing hub tailored for Black- and women-owned businesses. This initiative represents a significant investment in new jobs and opportunities for young people, highlighting the vital role of financial education in equipping our entrepreneurs with the tools they need to thrive.
- Furthermore, pregnancy-associated mortality continues to exhibit significant racial disparities, with Black women experiencing a death rate four times higher at 101.1 deaths per 100.000 live births compared to 23.9 deaths per 100,000 live births for White counterparts. I have been diligently working to raise awareness regarding failures to protect reproductive and maternal health, which constitute a violation of women's fundamental human rights. I am additionally advocating for treatment of women's chronic health disorders, such as fibroids, polycystic ovary syndrome (PCOS) and endometriosis, and passed Local Law 87 of 2022 (INTRO 482-A) requiring the City to disseminate crucial information to the public about these conditions.

In addition to these legislative achievements, I am grateful and honored to have been re-elected as Co-Chair of the Brooklyn Delegation alongside Council Member Chi Ossé, District 36, by my colleagues in the City Council.

I am incredibly proud to continue to represent our district and advocate for our interests at City Hall, and as we move forward, I look forward to engaging with you and our neighbors throughout the Spring, Summer and Fall. Together, we will continue working towards positive change and progress for our district.

I also had the privilege of attending the 52nd Annual New York State Association of Black, Puerto Rican, **Hispanic & Asian Legislators Conference** to panel on two discussions led by State Senators Cordell Cleare and James Sanders, Jr. focusing on reducing gun and domestic violence effectively for all district residents.

I also held a conversation with the Sororities of the Divine Nine to share and provide invaluable insights to address systemic issues facing women in New York City, including concerns about MWBE participation, civic education among our youth, and necessary policy changes to empower girls and women.

In March, I had the privilege of partnering with New York State Senator Kevin Parker to host an Interborough Express (IBX) townhall in our district to review the Governor's proposal to reactivate the LIRR Bay Ridge Branch with an innovative Workforce Development proposal, providing an opportunity for community members to review and discuss these vital initiatives. I am committed to having future conversations to address concerns such as eminent domain and construction impacts to neighboring residents.

During Preliminary Budget Hearings held by the City Council, I questioned the MTA on the impacts of congestion pricing to our communities in transit deserts, and hosted New York City Transit President Richard Davey in my district to ensure all of our communities' transit concerns are actively considered, and that all investments into our neighborhoods are done with community involvement first.
