IMMIGRATION POLICY TRACKING PROJECT

The Immigration Policy Tracking Project is a catalogue of immigration policies enacted by both Trump Administrations, including information on executive orders, legislation, and policy changes for federal agencies such as Immigration and Customs Enforcement (ICE). The website is updated regularly as new policies or executive orders are announced and enacted, and it keeps track of whether the policy is being enforced, has been rescinded, or is in partial effect.

The website is available in English.

IMMIGRANT ARC

One of the most thorough Know Your Rights resource guides, it provides information on general immigration, healthcare, housing, social and community services, food and clothing, education and childcare, and employment and financial information.

The website is available in Arabic, Chinese (Simplified), Chinese (Traditional), English, French, Portuguese, Spanish, and Russian. There are also 15 articles under the Immigration link that are available in Haitian Creole.

Know Your Rights with ICE

IMMIGRANT DEFENSE PROJECT

Provided by the Immigrant Defense Project, the first flyer on this page provides information on who is at risk of an interaction with ICE, arrest, and/or deportation and how to prepare.

The other flyers, infographics, and posters on this page provide further information. The booklet provides information on what kinds of warrants ICE must provide in order to legally enter a home along with your rights if they knock at your door. **If they do not have a warrant signed by a judge, you do not have to let them in.**

The first flyer is available in Arabic, Bengali, Chinese (Simplified), Chinese (Traditional), English, French, Haitian Creole, Hebrew, Hindi, Korean, Portuguese, Punjabi, Russian, Spanish, Tagalog, and Urdu.

The other flyers, infographics, the booklet, and posters are available in English and Spanish, and sometimes other languages such as Haitian Creole.

Deportation Defense Manual

MAKE THE ROAD NEW YORK

Provided by Make the Road New York, the manual provides information on three main categories: (1) one's rights when dealing with ICE and how to prepare; (2) steps to take when supporting an individual or family after an ICE raid; and (3) strategies for organizing around an individual case in your community.

Red Cards

IMMIGRANT LEGAL RESOURCE CENTER

Provided by the Immigrant Legal Resource Center, this helpful printable tool outlines one's basic constitutional rights so that immigrants can assert these rights and defend themselves from ICE overreach.

WE HAVE RIGHTS

This webpage provides helpful videos which explain when and where you might encounter ICE, how to respond if you encounter ICE, and how to prepare should you expect you might encounter ICE. It also provides a Preparedness Form, which gives helpful tips on preparing for potential ICE encounters.

The site offers videos in Arabic, Chinese (Simplified), English, Haitian Creole, Russian, Spanish, and Urdu. Not every video is available in every language, but each language has at least four of the five total videos available.

U.S. IMMIGRATION AND CUSTOMS ENFORCEMENT

This letter from ICE explains their policies for enforcement actions (arrests, interviews, searches, and surveillance) when located at sensitive locations. Sensitive locations include but are not limited to: (1)

schools; (2) hospitals; (3) places of worship; (4) the site of a funeral, wedding, or other public religious ceremony; and (5) the site of an ongoing public demonstration.

Request Records through the Freedom of Information Act or Privacy Act

U.S. CITIZENSHIP AND IMMIGRATION SERVICES

This site allows those who have lost copies of their documents to request their records. Those who do this on their own can speed up the process when they are connected with a lawyer as they will already have the required paperwork. To make the request, an active email address is required.
